### **Privacy Statement 2022**

#### General

The website and blog sites of A&S lawyers are owned and operated by A&S advocaten. A&S advocaten respects your privacy and ensures that the personal information you provide to us provided, confidentially and in accordance with the General Data Protection Regulation treated.

### Processing of personal data

Personal data is data that can be used to determine your identity. A&S advocaten makes a distinction between (1) personal data that you actively provide to us and (2) personal data that - for technical reasons - is automatically transmitted to us.

Personal data that you actively provide to us includes the name, contact details, preferences and other information you have provided to us (for example, during a registration procedure or during contact with a lawyer).

In addition, when you visit the Website, some technical data is automatically provided by your equipment to our computers, such as the IP address you use, the operating system, the internet browser used and (in some cases) the last internet page you visited.

#### **Processing purposes**

The personal data that A&S advocaten processes in the context of the website and blog sites will only be used for the following purposes:

- for the provision of the services offered;
- to be able to contact you;
- to inform you about new products and/or offers from A&S advocaten (whether or not focused on the areas of interest you have expressed);
- analysing and improving the services of A&S advocaten (including measuring and analysing statistical data regarding the
  use of A&S advocaten);
- conducting market research for A&S advocaten.

The processing of your personal data in any other way only takes place insofar you have given unambiguous consent and therefor authorized A&S advocaten to do so. This permission may be evidenced by the mere fact that you send an e-mail or otherwise ask A&S advocaten a question.

# Use of Google Analytics on the Website

The Website uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses "cookies" (text files that are placed on your computer) to help the website analyze how users use the site. The by the cookie generated information about your use of the website (including your IP address) is transferred to and by Google stored on servers in the United States. Google uses this information to keep track of how you use the website, prepare reports on website activity for website operators and offer other services related to website activity and internet usage. Google is allowed to provide this information to third parties if Google is legally obliged to do so, or to the extent that these third parties process information on behalf of Google. Google will not combine your IP address with other data about which Google features. You can refuse the use of cookies by selecting the appropriate setting on your browser settings. However, we would like to point out that in this case you may not be able to use all the possibilities of this website. If you do not want your website visit to be measured by Google Analytics, then you can download a tool that blocks Google Analytics. By using our website you consent to the processing of the information by Google in the manner and for the purposes as described above.

## **Amendments**

This Privacy Statement is subject to change. Changes will be announced on our website. A&S advocaten can process your personal data for new purposes that are not yet stated in this Privacy Statement. In that case, we will contact you before using your data for this new purposes, to notify you of changes to our protection rules of personal data and to give you the opportunity to refuse the use of your data for those purposes.
